RIIHAN301E OPERATE ELEVATING WORK PLATFORM

Course Overview

This course is designed for individuals working in operational roles seeking to develop skills and knowledge required to operate an elevating work platform at any height.

Course Duration

5 Days

Day 1 - Theory Training

Day 2 - Practical Training

Informal Training - 2 Days

Supervised practical (logbook hours)

As part of our service, we provide the opportunity for learners to develop the necessary practical skills required for assessment. The trainer will specify the amount of practice (log hours) required after formal training is completed and this is dependant on an individual's capability.

Note: Learners may require additional log hours to those included in the course to achieve competency. Those that require additional practice will be charged at a daily rate or hourly rate depending on their needs.

Rate – Day \$150 per day (7 hours)

Rate – Hourly \$30 per hour (up to 4 hours maximum then a daily rate is applicable)

Note: Informal Training may not happen over consecutive days depending on availability of machinery and equipment.

Topics Covered

- Plan and prepare for operating an elevating work platform
- Operate elevating work platform
- Conduct housekeeping activities

Assessment

1 day

A written and practical assessment is required to complete the unit successfully. Should re-assessment be required the fee is \$350.00 payable before attempt at assessment is conducted.

RIIHAN301E is a unit from the qualification RII30815 Certificate III in Civil Construction Plant Operations.

Pre-Requisites

Outcome

Upon successful completion of the course the student will be issued a nationally recognised training statement of attainment for the unit RIIHAN301E, Operate elevating work platform.
